The cleanup efforts were tremendous because of the thick mud. When the debris spilled over into the pool, it would take several days or more to drain the pool, get the debris out & refill the pool.
  - O Per pool vendor the pool flooded out at least twice or maybe more when the previous management company was in charge.
  - O Pet Waste Pick-up one time cleanup completed 05/01/22 & to continue monthly & evaluate services as needed.
  - O Pet station service increased from once p/w to twice p/w effective 06/01/22
